


## Overall objective of SR27

We don't know from the answers.


In most countries not selected/ Sept – end of Year.

### How to programme SV in LDS?

- Thematic approach (project-based)

   approx. 33% of answers (half of which refers to digital as well): wide range of themes (services, healt, education, tourism, transport, etc.
- Support, animation and capacitybuilding for communities – approx.
   22% of answers (c. half of which refers to strategy development at the local/community level)
- Other aspects (e.g. cooperation)
- Don't know.

"We would love to incorporate ideas and initiatives around revitalising rural services through digital and social innovation. Health, social services, education, energy, transport, retail — can be improved and made more sustainable through the deployment of Information and Communication Technology (ICT) tools and through community-led actions and projects."


"We are planning to develop 12 smart village strategies in our area. And also have a capital budget to deliver on innovative actions that arise from these strategies."

"We are planning to programme SV via cooperation projects to inspire communities to develop them in the rural territory of our LAG."


"We are not sure, therefore want to learn more."

"We are preparing Guidelines to support LAGs and Rural Authorities including smart villages in the regional policies and implementing them through LEADER. Moreover, we are constructing Smart Villages Taskforces to improve policy through the CAP Strategic Plan interventions."
