1. Context

The Smart Village (SV) approach is a completely new and an undiscovered concept for the communities in Latvia. The Ministry of Agriculture is currently the only state institution supporting the concept of Smart Villages - the policy maker. In the next CAP period 2023–2027, support for the development of the Smart Village approach in Latvia will be available under the LEADER program. However, a holistic approach to Smart Villages is very important and therefore requires a broader perspective and support for Smart Villages and rural communities.

Even though the approach of Smart Villages seems interesting and tempting to many, when you dig deeper it becomes clear that it is complicated and complex at the same time. It is therefore very important to inform the public and explain how it works and how it differs from, for example, the LEADER approach or citizen councils.

At the moment, there is no concrete approved definition of what a Smart Village is at the national level. The National Rural Network in its work with the concept of Smart Villages uses and accepts the definition set out in the SR21 project, while not particularly emphasising the need for digital technologies. Digital technologies are only relevant if they help and are useful to the rural community. It is intended that within the framework of working groups, its members - important promoters of rural development, etc., will mutually agree on a commonly used definition.

It is intended that the members of the working group will mutually agree on the necessary support for rural communities in the implementation of an effective and meaningful approach to Smart Villages, each of them determining their own contribution.

The Smart Villages (SV) process in Latvia is mainly driven by 3 categories of actors – national policy makers, national networks and NGOs:

- ✓ **The Ministry of Agriculture** is currently the only ministry that supports Smart Villages with funding opportunities. It ensured that Smart Villages receive support in the LEADER program to support the creation of Smart Villages;
- ✓ **The Ministry of Environmental protection and Regional Development** is the only ministry that has worked on the development and support of local strategies for villages. It has developed guidelines of development of village strategies;
- ✓ **The National CAP Network**, which has developed its own methodology in working with Smart Villages and which encourages active action by communities to promote the development of their territory;
- ✓ **The Latvian Rural Forum**, which implements territorial cooperation projects and community support projects in cooperation with local action groups. The organisation recognizes the needs of the communities and seeks opportunities to provide them;
- ✓ **LAGs** that are familiar with the Smart Village concept and Smart Village operational approach, are implementing territorial cooperation projects and solutions in cooperation with the communities in their territory.

The working group is intended to be formed as a broader representation of various sectors, including representatives of various ministries and organisations, researchers and promoters of rural development.

2. The purpose of the taskforce

Key policy areas of taskforce interventions (Summary)

- ✓ Create a multidisciplinary working group, bringing together representatives of various sectors and interests from various regions, thus promoting a holistic view and understanding of the concept of smart villages;
- ✓ Promote the cooperation of various interested parties for the development of the concept of Smart Villages;
- ✓ Promotion of public knowledge and common understanding;
- ✓ Create a support system for the smart village approach;
- ✓ Building policy co-responsibility.

The specific aims of establishing the Taskforce have been:

- Defining the state of play of Smart Villages at national level and defining the national principles of Smart Villages.
- Bringing together representatives of different EU funds, not only the representatives and stakeholders connected to CAP Strategic Plan 2023–2027.
- Proposing recommendations of the specific measures.
- Capacity building at local level, where it is needed or asked, including encouragement to create village strategies.
- Identification of villages-in-transition, Smart villages and StartUp villages.
- Promoting the SV approach in rural areas.
- Carry out a short study to prioritise the needs of rural communities.

Taskforce Action Plan

- Integrate results into the regular work of the relevant ministries and agencies (desirably it should result in changes to the legislation, and to the method / procedures of defining and developing policies).

3. Links to existing Smart Village exchanges

The actions are directly linked to communication/awareness actions carried out by the Latvian CAP Network Unit on the subject.

4. Membership

The membership of the taskforce includes representatives that are stakeholders connected to:

- public sector and policy planning, mostly the representatives from ministries, an association that unites and represents the interests of local governments,
- policy implementation, including representatives from LAGs and Regional institutions for municipal initiatives for joint development planning,
- public and private organisations, LEADER association,
- local authorities,
- research and innovation,
- networks, like the National NRN and community network,
- thematic experts on the different aspects of SV development,
- representatives of the rural areas, communities, and SVs.

5. Planned actions
