1. Context

Smart Villages has been programmed in the Hungarian CAP Strategic Plan and support is foreseen through a dedicated intervention: 'RD56: Rural development cooperation to support the digital transition of small settlements [smart village]'. Furthermore, intervention RD43: Rural infrastructure development in small settlements will also support/ complement Smart Villages developments.

Although Smart Villages is not directly supported under LEADER (intervention RD57: Preparation and implementation of LEADER strategies), the intervention is still relevant in the context of Smart Villages. One of the key roles of future LEADER LAGs is to "facilitate the preparation of smart village strategies" (HU CAP SP, p.1250)

Finally, capacity-building actions for Smart Villages are expected through intervention RD58: Training and demonstration programmes. This intervention concerns compulsory training for certain CAP Strategic Plan interventions, including RD56 on Smart Villages.

The above CAP SP interventions is the core of the Hungarian Smart Villages support framework.

There are also other national initiatives that are supporting Smart Village-type initiatives, in particular the Hungarian Village Programme¹ that supports the development of small towns and villages with population of no more than 5000 people in the field of rural services and infrastructure, support for rural civilian communities, improvement of housing conditions for people living in small settlements, development of inferior road network from domestic sources, and support for rural micro-enterprises from EU sources.

More specifically, the Digital Village Programme (DFP) was launched in 2021 to effectively support the improvement of the attractiveness and liveability of small villages through digital and smart solutions. The stated aim of the Digital Village Programme is to ensure the successful implementation of the tasks and indicators included in the objectives of the CAP Strategy, including the smart village initiative – although this programme is not directly referenced in the CAP SP.

Hungarian authorities – representatives of the Ministry of Agriculture and Managing Authority of the CAP SP - have been actively engaged in the European Commission's initiatives on Smart Villages. Among others, they closely followed the work of the Smart Rural 21 project and participated in several Smart Rural 21 events. There has been great interest on behalf of the MA to engage in Smart Rural 27 activities. Discussions have started among the MA representatives and the SR27 Team on how the planning of Smart Villages could be supported through the project, and about the setting up of a Hungarian Taskforce.

2. The purpose of the taskforce

Main objectives of the taskforce:

- ✓ Supporting the detailed design of SV intervention (if there is interest/ need from MA)
- ✓ Raise awareness and build capacity among relevant stakeholders: especially MA, LAGs ad rural communities for the effective implementation of Smart Villages

The main purpose of the taskforce is **to support the preparation and implementation of the Smart Villages interventions** in the CAP SP:

¹ The programme has been mostly supported from national resources. In 2021 the new component of Hungarian Village Startup Programme started to support micro-enterprises, which is supported from EU funding, namely by GINOP Plus (the Economic Development and Innovation Operational Programme)

- RD56: The implementation of this intervention has not yet started. The Smart Rural 27 project could potentially support the preparation of the intervention through advising on the (selection) criteria, especially with regard to the scope of smart village strategies, in particular through sharing information from other countries. If there is need, and agreed with the MA, a dedicated awareness-raising session for rural municipalities could be organised in order to share the experience of the Smart Rural 21 project.
- RD57: Supporting the implementation of Smart Villages (SV) through LEADER has been the
 initially defined focus and purpose of the taskforce activity in Hungary. LEADER LAGs are
 currently preparing their Local Development Strategies (LDSs) that are expected to be
 selected by November 2023. The aim was to raise awareness about the European
 experience of Smart Villages and to support LAGs to include Smart Villages into their LDSs.
- RD43: No specific activities have been foreseen in the context of this intervention, however, there is scope for the Smart Rural 27 project to share available experience in terms of relevant SV infrastructural developments and on how to create linkages with RD56, based on the Smart Rural 21 and Smart Rural 27 experience.
- RD58: It is suggested that in the capacity-building and training activities, the lessons learned and material developed through the Smart Rural 21 project is transposed into the Hungarian context. Further details are still to be discussed with taskforce members.

3. Links to existing Smart Village exchanges

No other Smart Villages exchanges have been identified, and therefore, the taskforce is not linking to existing SV platforms. The links to the Digital Village Programme need to be further explored in discussion with MA representatives.

4. Membership

The taskforce guidance to Smart Rural 27 national experts highlighted that "Taskforce members are normally stakeholders who:

- Has an interest in the SV theme
- Has an influence in the context of the policy / intervention that the Taskforce aims to influence
- Has an interest in working on the topic and exchange with other stakeholders within the Smart Rural 27 project Taskforce."

This is realised in the context of the Hungarian taskforce as follows:

- As specified above, taskforce discussions primarily started with representatives of the CAP
 MA that has both influence and interest in the Smart Villages theme.
- During the first phase of the taskforce activities, the focus has been on engaging LAGs that
 have an interest in Smart Villages through awareness raising & capacity-building on
 Smart Villages. The Hungarian LEADER Association also has an interest in the theme.
- Representatives of **the CAP Network** have also been informed and engaged in the activities. In the future, the taskforce could support the planning of CAP Network Smart Villages support activities, if there is interest.

5. Planned actions

Informal discussions with representatives of the Managing Authority

Although no formal taskforce meetings have been organised, informal discussions took place between the Managing Authority / Ministry of Agriculture representatives and the SR27 Team (in January, March, May 2023 at the Observatory meeting, and June/July in preparation for the LEADER training). During these discussions the scope of the first activity has been agreed. On 24 May 2023, the Smart Rural 27 Team made a presentation at the event of the Hungarian LEADER Association (LESZ), where the MA also participated, and among others highlighted the upcoming Smart Rural 27 LEADER capacity-building event and other possible synergies with the Smart Rural 27 project work.

LEADER capacity-building session: 11 July 2023

Based on initial/ informal discussions with the representatives of the Managing Authority, it had been decided to organise a dedicated taskforce meeting for LEADER LAGs, to raise awareness about the potential of Smart Villages and generate discussion on how Smart Villages could be better integrated into and supported by the LEADER LDSs.

This event was held on 11/07/2023 (see meeting report).

Planning meeting with taskforce members (Sept-Oct 2023 – tbc)

A meeting is planned in Sept/ Oct 2023 with taskforce members, to take account of the lessons learned through the LEADER capacity-building session and discuss next steps and activities in the Smart Villages planning. This opportunity will also be used to get an update on the planned timing and preparatory steps of the implementation of the Smart Villages interventions, and the identification of further possible support actions.

The discussion will be carried out with the MA representatives, with possible participation of other taskforce members, especially representatives of the CAP Network and the Hungarian LEADER Association.
