

# SMART VILLAGES WORKSHOP ON SUPPORTING SMART VILLAGES THROUGH LEADER Hungary, Budapest – 11 July 2023



#### Purpose of the meeting

The purpose of the workshop was to provide technical support to interested LEADER LAGs (Local Action Groups). The meeting aimed to clarify the relationship (differences and similarities) between the EU Smart Village initiative and LEADER, as well as provide guidance on how Smart Villages can be included and supported through the Local Development Strategies (LDSs).

### Main outcomes & lessons learnt (including deviations from initial plan)

The workshop took place with the participation of the Hungarian CAP Network, Managing Authority (MA), and 23 Local Action Groups (LAGs) from different parts of the country. The event began with an introduction to the Smart Rural 27 project and the Hungarian Smart Village taskforce, led by Edina Ocsko. Presentations focused on international experiences and connections between Smart Villages and LEADER.

The MA presented the current status of the Smart Village intervention within the Hungarian CAP Strategic Plan, covering beneficiaries, eligibility criteria, commitments, selection, budget, and financial aspects.

The workshop addressed the integration of Smart Villages into LEADER, allowing LAGs to exchange ideas, questions, and provide ideas on how to support local municipalities in







developing and implementing Smart Village concepts. The workshops presented effective approaches of Smart Villages and LEADER initiatives building on the previous experience and knowledge of the Smart Rural 21 project.

Based on the questions formulated during the session and the feedback after the session, LAGs emphasised the importance of having a sample concept for Smart Villages and sought clearer understanding about how the Smart Village initiative is linked to LEADER. The MA received numerous questions regarding the SV intervention. However, the since the concrete implementation of the interventions have not yet started, there is still no clarity on the implementation details.

The participating LAGs emphasised the significance of such meetings for idea exchange and information sharing, underscoring the need for continuous support and assistance. They suggested comparing LEADER-funded applications with Smart Village (SV) funding applications in terms of support intensity and conditions. This could help the application process, collaboration benefits with local governments, and the extent of support. Additionally, they emphasised the value the possibility of ongoing training for LAGs about Smart Villages.

Although further discussions are need, the event provided clarity on the differences between Smart Villages and LEADER. Most important it was discussed that while the LEADER principles also apply for Smart Villages, the main difference is that strategy is developed and actions implemented under the SV concept at the *local community level*, i.e. the aim is that LEADER LAGs work closely with municipalities supporting them to develop their own vision and strategy at the municipality level and helping them implementing smart actions.

Some LAGs see the possibility in supporting SV directly or integrating SV concepts into the LDS. Two options are proposed: supporting the creation of Smart Village Strategies with targeted funds and/or providing funding for the implementation of smart projects (e.g. through dedicated smart village calls).

#### Next steps

Further discussions will be carried out with the MA and other stakeholders to support SV intervention / call design.

Further capacity-building events are foreseen for LAGs and interested municipalities (to be agreed with the MA) in early 2024.
